We preserve and restore key local ecosystems to maintain the physical and biological integrity that will allow wildlife to move across their historic ranges and for their habitats to thrive.

Advancing Innovative Policy - Stainable conservation gains must be supported by governments via laws, regulations, and programs. We advance adoption of legal frameworks built around the needs of nature. This year, we collaborated with conservation nonprofits and government officials to advance the Wildlife Corridors Conservation Act, which passed the House of Representatives in July 2020.
